- **3** The statutory functions involve:
- administering the trade mark registration system by examining trade mark applications, conducting registrability and opposition hearings, maintaining the register of trade marks and making it available for public search;
- administering the patents registration system by granting short-term patents, registering patents granted by designated Patent Offices, maintaining the register of patents and making it available for public search;
- administering the designs registration system by processing design applications, maintaining the register of designs and making it available for public search; and
- administering the registration system of copyright licensing bodies by processing applications for registration and applications for renewal of registration, maintaining the register of copyright licensing bodies and making it available for public search.

5 During 2002–03, the department launched, on a trial basis, on-line search of the trade marks register, hence over 200% increase in the number of public searches estimated for 2003. The department also maintained the 2001–02 level of resolution of trade mark cases that were ready for hearing.

6 The new Trade Marks Rules under the new Trade Marks Ordinance are targeted for commencement in the first half of 2003 with reduction of trade mark fees.

#### Matters Requiring Special Attention in 2003–04

7 We envisage that other e-business facilities e.g. e-filing, e-payment and on-line inspection of documents will be delivered in 2003 for trade marks, patents and registered designs. We shall focus on introducing user-friendly e-business facilities to our customers.

8 We shall also focus on enhancing the capacity of our staff to issue consistent and definitive first examination reports. We intend to deliver registration of trade marks under the e-business model in an efficient and user-friendly manner.

**9** The anticipated increase of registrability hearings during 2002–03 materialised (up 70% compared with 2001–02). On the basis of overseas experience, we anticipate a further substantial initial increase of requests for registrability hearings upon the commencement of the new Trade Marks Ordinance in the first half of 2003.

#### Aim

10 The aim is to promote awareness of intellectual property rights, to enhance the reputation of Hong Kong in the protection of intellectual property rights in order to attract investment, to protect existing and new types of intellectual property rights in line with international standards, and to pay particular attention to laws required to fight against copyright piracy and trade mark counterfeiting.

#### **Brief Description**

**11** This programme area involves:

- advising the Secretary for Commerce, Industry and Technology on policies and legislation to protect intellectual property in Hong Kong and providing civil legal advice on intellectual property matters to government bureaux and departments;
- advising the Secretary for Commerce, Industry and Technology on developments at the World Intellectual Property Organisation, World Trade Organisation (WTO) and Asia-Pacific Economic Cooperation (APEC);
- participating in consultations, negotiations and committees of experts leading to new or revised international intellectual property rights standards; attending and participating in international seminars, conferences, meetings, etc. on intellectual property rights matters; and
- in response to increasing integration of the economic activities of the HKSAR and Guangdong Province in the Pearl River Delta (PRD), the department has increased co-operation with Provincial authorities to assist HKSARbased enterprises in protecting their intellectual property assets.

12 Since 1999, the department has commissioned an annual survey to measure changes in people's awareness of intellectual property and to assess the effectiveness of our promotion and public education programmes. The result of the survey in consecutive years has shown that there have been increases in the percentages of the public who have a good understanding of intellectual property rights.

13 Another priority of the department is to assist small and medium enterprises (SMEs) in matters relating to the protection of intellectual property rights. The department has organised and participated in various seminars explaining the protection of intellectual property to SMEs in different industries e.g. toys, watches, garments. The department will continue to strengthen its support for SMEs.

14 During 2002–03, the department increased its territory-wide campaigns such as the "No Fakes" Pledge and the "I Pledge" Campaign. The "I Pledge" Concert, which promoted commitment to use and buy only genuine goods and products, was held in the Hong Kong Coliseum in November 2002. The department also participated in various exhibitions, including the SME Market Day, Comics Festival, Business of Design Week 2002, World Congress of Accountants Hong Kong 2002, Hong Kong Computer Festival and Asia Game Show. A road-show exhibiting the history, functions, roles and missions of the department was staged in a popular shopping centre to celebrate the fifth year of the HKSAR.

15 Through seminars and other fora for school principals, teachers, school administrators, librarians, business organisations and civil servants, the department raised their level of knowledge about intellectual property and promoted compliance with intellectual property rights.

16 The department continued its secondary school visits programme into the sixth year. The objective is to encourage an attitude among students of respecting intellectual property rights. In 2002, we reached 75 schools and 23 057 students under this programme.

17 The department is co-operating in setting up an intellectual property protection information database with focus on Guangdong Province, the PRD, the Macao SAR and the HKSAR. A fact-finding study funded by the United Nations Development Programme was conducted in Guangdong Province with the objective of gaining a better understanding of the intellectual property protection systems in the Mainland, especially in the PRD. Activities being planned include a SME seminar with Trade Development Council and a workshop/road-show for SMEs in Guangdong. The outcome of these activities will provide a better business support framework for Hong Kong businessmen in Southern China.

18 In collaboration with Radio Television Hong Kong, the department produced an eight-episode TV series "Treasure Trove of Ideas" with a comprehensive coverage on various intellectual property rights. The series was broadcast on television for eight consecutive weeks in August and September 2002.

**19** As part of our customer relationship management, we organised a briefing on the new Trade Marks Ordinance on 22 November 2002. A series of workshops to familiarise legal practitioners with the new Trade Marks Ordinance was held in January to March 2003.

# Matters Requiring Special Attention in 2003-04

**21** During 2003–04, the department will:

- advise the Secretary for Commerce, Industry and Technology on making permanent the suspension arrangement under the Copyright (Suspension of Amendments) Ordinance 2001 and other related amendments to the Copyright Ordinance and other issues raised as part of the follow-up of the copyright consultation exercise held in late 2001;
- continue to participate in other international intellectual property activities;
- continue to play a pro-active role in APEC and the Trade-Related Aspects of Intellectual Property Rights Council of the WTO, and through such institutions to provide appropriate technical assistance to developing and least-developed economies overseas;
- participate in activities organised by various institutions in Hong Kong on intellectual property protection for Hong Kong businessmen in Southern China;
- organise seminars, exhibitions and fairs on intellectual property;
- disseminate information through the internet on the intellectual property systems in the Mainland, HKSAR and Macao SAR; and
- strengthen out-reach to young people on intellectual property protection through media such as computer games and comics.



# Programme (1)


Provision for 2003–04 is \$20.7 million (22.8%) higher than the revised estimate for 2002–03. This is mainly due to salary increments for staff and increased cashflow requirement for outsourcing of non-core services of the department, partly offset by the full-year savings of posts deleted in 2002–03, the net deletion of one post and reduced operating expenses through efficiency savings.

#### Programme (2)

Provision for 2003–04 is \$2.3 million (13.3%) lower than the revised estimate for 2002–03. This is mainly due to the lapse of a supernumerary post for accommodating an officer on pre-retirement leave in 2002–03 and reduced cashflow requirement upon completion of a capital project.

#### **Details of Expenditure by Subhead**

The estimate of the amount required in 2003–04 for the salaries and expenses of the Intellectual Property Department is \$126,542,000. This represents an increase of \$18,434,000 over the revised estimate for 2002–03 and of \$34,960,000 over actual expenditure in 2001–02.

#### Recurrent Account

**2** Provision of \$70,901,000 under *Subhead 000 Operational expenses* is for the salaries and allowances of staff of the Intellectual Property Department and its other operating expenses. The decrease of \$4,539,000 (6.0%) against the revised estimate for 2002–03 is mainly due to the full-year savings of posts deleted in 2002–03, lapse of a supernumerary post for accommodating an officer on pre-retirement leave in 2002-03, the net deletion of one post and reduced operating expenses through efficiency savings, partly offset by salary increments for staff.

**3** The establishment as at 31 March 2003 will be 104 permanent posts. It is expected that there will be a net deletion of one post in 2003–04. Subject to certain conditions, the controlling officer may under delegated powers create or delete non-directorate posts during 2003–04, but the notional annual mid-point salary value of all such posts must not exceed \$47,309,000.
