#### Aim

2 The aim is to maintain law and order through the deployment of efficient and well-equipped uniformed police personnel throughout the land regions.

#### **Brief Description**

**3** Law and order is maintained primarily through the deployment of uniformed officers to project highly visible and mobile police presence. The constant monitoring of crime trends, judicious planning for public events and the use of an enhanced computer-assisted command and control system allow for the effective and efficient deployment of police resources.

- 4 In 2002, the Force:
- extended the trial scheme using vehicle patrols to increase coverage and to enhance response to emergencies in rural/remote areas to Hong Kong Island and Kowloon East;
- introduced a new public relations strategy, involving all levels within the Force, to project a strong positive Force image with a view to maintaining a high level of public support and participation in upholding law and order in the community;
- commissioned one customer satisfaction survey;
- continued to implement the two-pronged internal communications strategy to improve communications systems and practices whilst instilling a positive attitude to gain staff commitment to achieve the Force's objectives;
- continued to upgrade existing police premises under the Station Improvement Project, which is scheduled for completion by the end of 2002–03;
- conducted a feasibility study on introducing a Service Quality Award Scheme to promote and reinforce a quality service culture in the workplace;
- introduced a revised programme management system which utilises information technology and performance measures to allow for more efficient monitoring and management of Force projects; and
- established the foundation for the development of a Force-wide knowledge management system which enables the systematic capturing, storing and utilisation of organisational and individual knowledge.

#### Aim

7 The aim is to prevent and detect crime.

## **Brief Description**

**8** The prevention and detection of crime is a Force-wide priority with crime units, supported by uniformed officers, under a unified police command. This work involves:

- investigations by crime units in Police headquarters, regions, districts and divisions;
- developing the Force's various information and intelligence systems—in particular, strengthening its crime investigation capabilities through the use and development of various modern technologies;

- · maximising the use and effectiveness of computer systems and other intelligence gathering procedures;
- mounting crime prevention publicity programmes; and
- maintaining close liaison and cooperation with police authorities of the Mainland and other jurisdictions.
- **9** In 2002, the Force:
- implemented the Massage Establishment (Amendment) Ordinance enacted in November 2001;
- continued to work closely with Home Affairs Bureau and District Fight Crime Committees (DFCCs) to launch regular crime prevention initiatives, which included 'Help People to Help Themselves—Fight Crime Campaign', 'Fight Crime Game Stall Competition' and '18 Districts Fight Crime Carnival';
- worked closely with Junior Police Call (JPC) Honorary Presidents to identify and implement Force-wide anticrime initiatives, and carried out 143 activities including 'JPC Fight Crime Summer Camp', 'No Drug Action Basketball Competition' and 'Help the Police to Fight Youth Crime Competition';
- launched the Secondary School Liaison Programme to enhance police liaison with secondary schools, Education Department (ED), Social Welfare Department (SWD) and non-government organisations in tackling juvenile delinquency and crime;
- reviewed 47 multi-agency youth initiatives in various Police regions and districts. 'Smart Teen Challenge Camp' coordinated by the Force and ED remained a project identified suitable for Force-wide implementation. A total of 8 courses were run for 848 students in 2002. SWD and Narcotics Division of Security Bureau also assisted in the training and evaluation of the programme;
- organised anti-crime publicity programmes to address specific crime problems namely, 'Anti-shop Theft', 'Antidomestic Burglaries', 'Street Deception' and 'Computer Crime Involving Youngsters';
- tackled organised crimes, particularly crimes involving firearms, triad, soccer bookmaking, money laundering, syndicated vice and frauds through strengthened intelligence network, intelligence-based investigations and undercover operations with emphasis on attacking the financial sources behind these organised crimes;
- maintained operational liaison and bilateral relationships with the Mainland authorities in combating crossboundary organised crimes;
- conducted territory-wide crackdowns against drugs and psychotropic substances with operational support of the Mainland counterparts and law enforcement agencies in neighbouring cities and overseas countries;
- maintained close cooperation and liaison with overseas law enforcement agencies in addressing cross-border crimes and exchange of intelligence, skills and experiences;
- successfully held a Transnational Organised Crime Conference, which aimed to enhance international cooperation with focuses on triad, narcotics, money laundering and cyber crime, with a participation of over 500 local and overseas delegates;
- increased video interview rooms to 69 with a significant increase in the usage of these facilities, and introduced criteria to relax the video interview application for suitable Magistrates' court cases;
- pursued the upgrading of the existing intelligence processing computer system to enhance the Force's intelligence analysis and serious crime investigation capability;
- provided special training programmes for handling child abuse investigations and streamlined joint agency investigation procedures into child abuse, the Police Superintendent's Discretion Scheme and juvenile crime;
- improved the witness and victim support schemes with the completion of eight additional one-way-viewer identification parade suites; and
- enhanced enforcement capability against technology crime by strengthening the expertise of investigation officers and established a professional Computer Forensics Laboratory.

## **Brief Description**

13 Reduction in the number of traffic accidents is achieved through:

- educating the public on road safety;
- · enforcing road traffic legislation; and
- advising on engineering improvements to the road infrastructure.

14 In 2002, the Force:

- continued to assist the Environment, Transport and Works Bureau (ETWB) in reviewing legislation on the use of vehicle headlights and hazard warning lights during hours of darkness or poor visibility;
- continued to launch the new automated computer case processing system with full scale implementation in 2003; and
- recruited and trained 183 road safety patrol members under the Road Safety Town Assistant Pioneer Scheme to instil road safety awareness in visitors to Road Safety Towns.

**15** The key performance measures are:

These include:

- greater focus on education, particularly of professional drivers, and of young and elderly pedestrians, in road safety matters;
- strengthening traffic law enforcement against offences which are leading factors in causing accidents—such as

## **Brief Description**

**18** The programme includes:

- co-ordinating Force deployment on anti-illegal immigration and anti-smuggling operations;
- maintaining readiness to react swiftly and effectively to cope with any type of major incident, disaster, civil disturbance or terrorist incident;
- providing reinforcement—particularly Police Tactical Unit, Marine and Auxiliary Police personnel—for operations to maintain law and order in the community; and
- providing enhanced training in all areas of internal security and crowd management to ensure the maintenance of law and order.

**19** In 2002, the Force:

- enhanced its operational readiness and capability through exercises and updating of orders and equipment in order to be able to respond to terrorist attacks;
- continued to improve the Force's capability in the prevention and management of disasters through training and exercises;
- strengthened the collaboration with other emergency services in enhancing government responses to major incidents and emergencies;
- improved the resources support to officers undergoing training on crowd management and internal security situation through training enhancement and review of personal protective equipment;
- continued to draw reference from overseas organisations to ensure that the Force's capability in handling public order, internal security or international terrorism was in step with prevailing global trends;
- deployed resources for the policing of a series of international events including provision of security measures for visiting foreign dignitaries and national leaders;
- enhanced liaison with the Mainland counterparts and upgraded technical equipment to prevent and interdict illegal immigration along the land boundary with Shenzhen;
- continued to liaise closely and exchange intelligence with the Mainland counterparts to combat illegal immigration activities by sea;

- continued to upgrade technical equipment for Marine Police to enhance navigational safety and effectiveness in search and rescue operations as well as operational efficiency and actions against illegal immigration activities by sea;
- continued to work closely with both the Mainland counterparts and the Customs and Excise Department to counter cross-boundary smuggling by sea;
- took delivery of two surveillance barges and six high-speed interceptors and two replacement vessels for Marine Police; and
- completed tendering for the procurement of a new command and control communications system (CC III) to replace the present system (CC II) to enhance operational efficiency and quality of service.

- detection and interdiction of illegal immigrants entering Hong Kong at land and sea boundaries;
- reduction of the resident illegal immigration population in Hong Kong by mounting intelligence-based operations;

- continue to improve the Force's capability in the prevention and management of disasters through training and exercises;
- implement a revised training schedule to better meet the changing training requirements of the Police Tactical Unit while improving human resource management and cost effectiveness of training resources;
- develop and provide new operational and tactical training courses to enhance the Force's operational capability;
- continue to review tactics, equipment, arms and ammunition to sustain the Force's capability in policing public order and internal security situation;
- continue to strengthen the collaboration with other emergency services with a view to enhancing government responses to major incidents and emergencies;

#### Analysis of Financial and Staffing Provision

#### Programme (1)

Provision for 2003–04 is \$16.6 million (0.3%) lower than the revised estimate for 2002–03. This is mainly due to the full-year effect of civil service pay cut in 2002 and deletion of 69 posts to achieve efficiency savings in 2003–04; partly offset by salary increments for staff, full-year provision for posts created in 2002–03 and creation of 29 posts for expansion of operational capability in Lok Ma Chau Border Crossing Point in 2003–04.

#### Programme (2)


Provision for 2003–04 is \$27.1 million (1.1%) lower than the revised estimate for 2002–03. This is mainly due to the full-year effect of civil service pay cut in 2002 and deletion of 39 posts to achieve efficiency savings in 2003–04; partly offset by salary increments for staff and full-year provision for posts created in 2002–03.

#### Programme (3)


Provision for 2003–04 is \$0.4 million (0.0%) higher than the revised estimate for 2002–03. This is mainly due to the full-year provision for posts created in 2002–03, salary increments for staff and net creation of 11 posts (creation of 31 posts, offset by deletion of 20 posts) for strengthening operational front-line capability in new infrastructures in 2003–04; partly offset by the deletion of ten posts to achieve efficiency savings in 2003–04 and full-year effect of civil service pay cut in 2002.

#### **Programme** (4)

Provision for 2003–04 is \$66.4 million (2.6%) lower than the revised estimate for 2002–03. This is mainly due to the deletion of 208 posts to achieve efficiency savings in 2003–04, full-year effect of civil service pay cut in 2002 and reduced requirement for allowance; partly offset by salary increments for staff.

#### **Details of Expenditure by Subhead**

The estimate of the amount required in 2003–04 for the salaries and expenses of the Hong Kong Police Force is \$12,189,767,000. This represents a decrease of \$109,774,000 against the revised estimate for 2002–03 and an increase of \$69,531,000 over actual expenditure in 2001–02.

#### Recurrent Account

2 Provision of \$11,942,150,000 under *Subhead 000 Operational expenses* is for the salaries and allowances of staff of the Hong Kong Police Force and its other operating expenses.

**3** The establishment as at 31 March 2003 will be 34 302 permanent posts. It is expected that a net 286 permanent posts will be deleted in 2003–04. Subject to certain conditions, the controlling officer may under delegated powers create or delete non-directorate posts during 2003–04, but the notional annual mid-point salary value of all such posts must not exceed \$9,335,043,000.
