Aim

2 The aim is to administer efficiently and cost-effectively various student financial assistance schemes, scholarships and merit award schemes.

Brief Description

3 The Agency provides publicly-funded financial assistance in the form of grants and loans to students of different levels and administers privately-donated and publicly-funded scholarship schemes. The scholarships, merit awards and related schemes include the Sir Edward Youde Memorial Fund Scholarships and some 170 scholarships under the Education Scholarships Fund. Financial assistance mainly takes the form of:

- means-tested grants and loans# under the Local Student Finance Scheme for eligible full-time students of publiclyfunded institutions, i.e. University Grants Committee - funded institutions, the Hong Kong Institute of Vocational Education of the Vocational Training Council, the Hong Kong Academy for Performing Arts and the Prince Philip Dental Hospital (as relates to the Dental Technology Course);
- means-tested grants and loans# under the Financial Assistance Scheme for Post-secondary Students for eligible full-time students aged 25 or below pursuing accredited, self-financing post-secondary education programmes;
- means-tested grants and loans# under the Student Finance Assistance Scheme for eligible full-time students registered in the 2000/01 academic year or before at the Hong Kong Shue Yan College (HKSYC);
- non-means tested loans# for eligible students of publicly-funded institutions, the Open University of Hong Kong, the HKSYC, accredited post-secondary institutions and persons pursuing continuing and professional education courses provided in Hong Kong by registered schools, non-local universities and professional and recognised training bodies;
- allowances under the Student Travel Subsidy Scheme for needy students who are receiving formal primary or secondary education or attending a full-time day course up to first degree, provided that these students are living beyond ten minutes' walking distance from their schools and have passed the means test;
- fee remission under the Senior Secondary Fee Remission Scheme§ for needy senior secondary students (Secondary 4-7) in public sector schools and the Examination Fee Remission Scheme for needy Secondary 5 and Secondary 7 students taking public examinations conducted by the Hong Kong Examinations and Assessment Authority;

- means-tested grants under the School Textbook Assistance Scheme for students in public sector schools and local private schools under the Direct Subsidy Scheme;
- · fee remission under the Kindergarten Fee Remission Scheme for needy kindergarten pupils; and
- tuition fee reimbursement under the Continuing Education Fund for eligible persons pursuing continuing education and training in specified sectors.

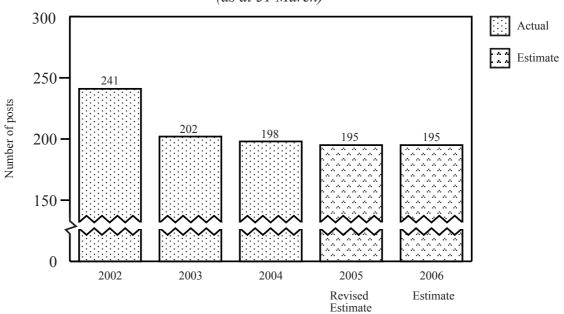

Analysis of Financial and Staffing Provision

Provision for 2005–06 is \$657.4 million (21.4%) higher than the revised estimate for 2004–05. This is mainly due to an expected increase in the demand for financial assistance under the Financial Assistance Scheme for Post-secondary Students arising from the on-going expansion of post-secondary education opportunities, an anticipated increase in payments for reimbursement of course fees under the Continuing Education Fund, and an expected increase in the number of successful applications and in the average levels of assistance under various student financial assistance schemes.

Details of Expenditure by Subhead

The estimate of the amount required in 2005–06 for the salaries and expenses of the Student Financial Assistance Agency is \$3,722,780,000. This represents an increase of \$657,367,000 over the revised estimate for 2004–05 and of \$1,013,210,000 over actual expenditure in 2003–04.

2 Provision of \$138,802,000 under *Subhead 000 Operational expenses* is for the salaries, allowances and other operating expenses of the Student Financial Assistance Agency. The increase of \$7,216,000 (5.5%) over the revised estimate for 2004–05 is mainly due to increased provision for temporary staff and other departmental expenses to cater for anticipated increases in caseload.

3 The establishment as at 31 March 2005 will be 195 permanent posts. No change in establishment is expected by 31 March 2006. Subject to certain conditions, the controlling officer may under delegated power create or delete nondirectorate posts during 2005–06, but the notional annual mid-point salary value of all such posts must not exceed \$61,335,000.

5 Provision of \$2,794,366,000 under *Subhead 228 Student financial assistance* is for the payment of financial assistance under various schemes to students of all levels of study in meeting their education expenses, such as tuition and examination fees, textbooks and other academic and travel expenses. The increase of \$139,145,000 (5.2%) over the revised estimate for 2004–05 is mainly due to expected increase in the demand for financial assistance under the Financial Assistance Scheme for Post-secondary Students arising from the on-going expansion of post-secondary education opportunities and projected increases in the number of successful applicants and in the average levels of assistance under various student financial assistance schemes.
