Aim

2 The aim is to assist in maintaining an efficient and stable civil service through the advice of the advisory bodies.

Brief Description

- 3 The four advisory bodies advise the Chief Executive on the following:
- Standing Commission: Civil Service matters relating to the pay and conditions of service of the non-directorate civil service;
- Standing Committee: Disciplined Services matters relating to the pay and conditions of service of the disciplined services;
- Standing Committee: Directorate the structure of directorate posts and matters relating to pay and conditions of service: and
- Standing Committee: Judicial Services the structure of judicial posts and matters relating to pay and conditions
 of service.
- **4** The advisory bodies take into consideration recommendations from the Administration and views of the staff before tendering their advice to the Chief Executive.
- 5 The effectiveness of the work of the advisory bodies is reflected in the part they play in the formulation of reasonable principles and viable practices governing the grades, ranks, salary structures and conditions of service of the civil and judicial services.

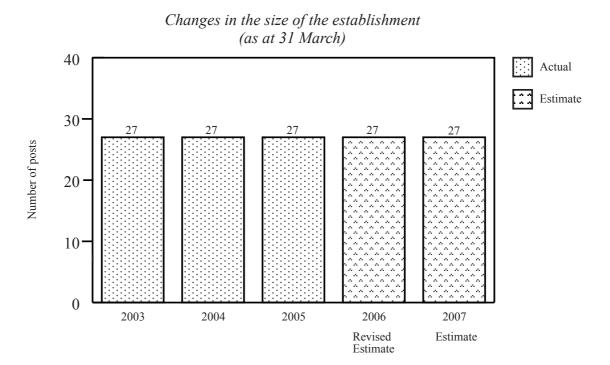
- 6 During 2006–07, the advisory bodies will:

Details of Expenditure by Subhead

The estimate of the amount required in 2006–07 for the salaries and expenses of the Joint Secretariat for the Advisory Bodies on Civil Service and Judicial Salaries and Conditions of Service (Joint Secretariat) is \$8,650,000. This represents a decrease of \$1,873,000 against the revised estimate for 2005–06 and of \$1,179,000 against actual expenditure in 2004–05.

- **2** Provision of \$8,650,000 under *Subhead 000 Operational expenses* is for the salaries, allowances and other operating expenses of the Joint Secretariat. The decrease of \$1,873,000 (17.8%) against the revised estimate for 2005–06 is mainly due to the reduced salary provision arising from staff changes and the reduced requirement for general departmental expenses.
- **3** The establishment as at 31 March 2006 will be 27 permanent posts. No change in establishment is expected by 31 March 2007. Subject to certain conditions, the controlling officer may under delegated power create or delete non-directorate posts during 2006–07, but the notional annual mid-point salary value of all such posts must not exceed \$9,259,000.
