Aim

2 The aim is to facilitate agricultural and fisheries production and improve productivity.

Brief Description

3 The department provides infrastructural support services to promote efficient production of local farming, capture fisheries and aquaculture industries and sustainable development of agriculture and fisheries in Hong Kong. The work involves:

- the introduction of modern technology and the provision of technical advice, assistance and credit facilities to local agricultural producers with a view to maximising yields and improving the quality of local products;
- the provision of fisheries development, extension and management activities including technical studies, surveys, assistance and advice, and vocational training to fishermen for improving the productivity of the fisheries sector;
- law enforcement in the fields of fisheries and fish culture; and
- the provision of administrative and technical support to the operation of the Vegetable Marketing Organisation and the Fish Marketing Organisation.

4 The performance targets of the programme were satisfactorily achieved in 1999. Agricultural production remained steady in general. The accredited vegetable farm scheme continued to expand in 1999. The overall fisheries production declined in the year mainly due to a general decline in fisheries resources in our traditional fishing grounds. To promote sustainable development of the fishing industry, an appropriate fisheries management strategy is being formulated. Legislative amendments have also been made to the Fisheries Protection Ordinance and the control over destructive fishing has been extended to cover electro-fishing and clam harvest by suction and dredging devices. The

deployment of artificial reefs in marine parks was successfully completed. The Mainland Fishermen Deckhands Scheme was expanded to help alleviate labour shortage problem of the fishing industry. The fish health management service has been expanded to help fish farmers minimise losses due to fish diseases. The red tide consultancy study was completed and an enhanced red tide action plan has been implemented to minimise the impacts of red tide on mariculture.

6 In agriculture, emphasis will continue to be given to the implementation and extension of accredited vegetable farm scheme and the promotion of intensive production, improved new plant varieties and livestock breeds. In capture fisheries, efforts will be devoted to enhancing and conserving fisheries resources through the implementation of one or more fisheries resources management measures as agreed by the Working Group on Fisheries Management, the deployment of artificial reefs and the study on the feasibility of developing an offshore fishing industry. 16 The government plans to build a multi-storey wholesale market complex in Cheung Sha Wan to accommodate fresh food produce wholesale activities in Kowloon, including the reprovisioning of the Yaumatei Fruit Market, the Cheung Sha Wan Temporary Wholesale Poultry Market and the wholesale vegetable market of the Vegetable Marketing Organisation. Aim

17 The aim is to monitor the welfare of, and control the disease in, animals and plants through enforcement of relevant legislation, and to provide technical services.

Brief Description

18 The department is responsible for prevention of the introduction and spread of animal and plant diseases, safeguard of animal welfare, provision of services to facilitate export of plants, animals and plant/animal by-products, prevention of rabies and enforcement of regulations pertaining to animal welfare and import requirements. The work involves:

- the prevention and control of rabies;
- the provision of quarantine services;
- the inspection of animals and plants imported into the territory;
- the inspection of premises and establishments where animals are kept for exhibition or trading purposes; and
- the instigation of prosecution against offenders under relevant legislation.

19 The technical services provided by the department include:

- advising on development projects affecting agriculture, countryside and fisheries, and assessing ex-gratia payments to primary producers arising therefrom;

ANALYSIS OF FINANCIAL PROVISION

Analysis of Financial and Staffing Provision

Programme (1)

Provision for 2000–01 is \$16.0 million (13.4%) higher than the revised estimate for 1999–2000. This is mainly due to increases in capital expenditure, full-year provision for posts created in 1999–2000 and creation of one post in 2000–01 for a project to translate by-laws, partly offset by the deletion of one post in 2000–01 under the Enhanced Productivity Programme.

Programme (2)

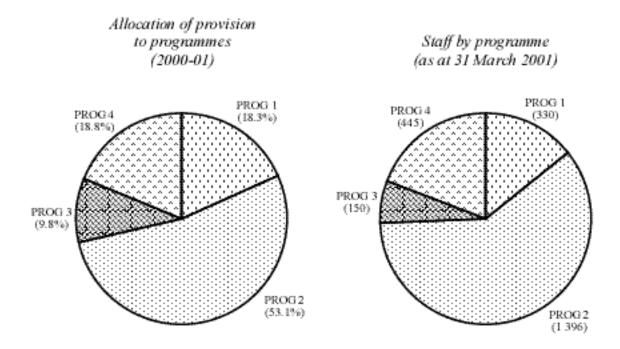
Provision for 2000–01 is \$10.2 million (2.7%) higher than the revised estimate for 1999–2000. This is mainly due to salary increments for existing staff, full-year provision for filling of vacancies and posts created in 1999–2000 and the creation of seven posts in 2000–01, including four posts for management of the wetland at Tin Shui Wai and three posts for other projects, partly offset by the deletion of 19 posts in 2000–01 under the Enhanced Productivity Programme and deletion of three other posts upon completion of a capital project.

Programme (3)

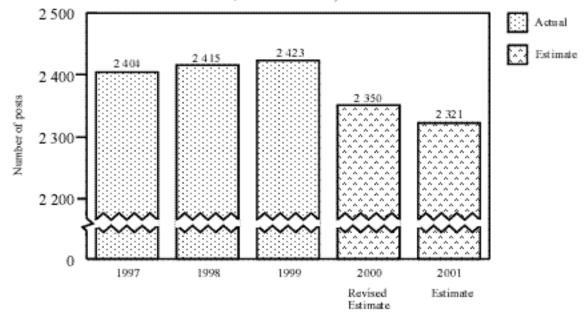
Provision for 2000–01 is \$10.9 million (13.0%) lower than the revised estimate for 1999–2000. This is mainly due to reduced requirement in capital expenditure, full-year savings arising from the deletion of five posts in 1999–2000 and deletion of ten posts in 2000–01 under the Enhanced Productivity Programme.

Programme (4)

Provision for 2000–01 is \$12.1 million (8.0%) lower than the revised estimate for 1999–2000. This is mainly due to transfer of financial provision and deletion of 89 posts in 1999–2000 following the re-organisation of municipal services, full-year savings arising from the deletion of another 45 posts in 1999–2000 and four posts in 2000–01 all under the Enhanced Productivity Programme, partly offset by full-year provision for posts created in 1999–2000.

Details of Expenditure by Subhead

The estimate of the amount required in 2000–01 for the salaries and expenses of the Agriculture, Fisheries and Conservation Department is \$743,022,000. This represents an increase of \$3,187,000 over the revised estimate for 1999–2000 and of \$61,251,000 on actual expenditure in 1998–99.

Recurrent Account

Personal Emoluments

2 Provision of \$536,442,000 for personal emoluments represents a decrease of \$10,722,000 against the revised estimate for 1999–2000 and takes into account salary increments for existing staff, full-year savings arising from posts deleted in 1999–2000 and expected changes in establishment in 2000–01.

3 The establishment at 31 March 2000 will be 2 350 permanent posts. It is expected that a net 29 permanent posts will be deleted in 2000–01.

4 Subject to certain conditions, the controlling officer may under delegated powers create or delete non-directorate posts during 2000–01, but the notional annual mid-point salary value of all such posts must not exceed \$496,745,000 which will be reduced to \$494,337,000 upon deletion of seven posts in the course of the year.

5 Provision of \$13,176,000 under *Subhead 002 Allowances* is for standard allowances and the following non-standard allowance—

6 Provision of \$9,522,000 under *Subhead 007 Job-related allowances* is for standard job-related allowances and the following non-standard job-related allowance—

7 Provision of \$121,045,000 under *Subhead 149 General departmental expenses* represents an increase of \$8,738,000 (7.8%) over the revised estimate for 1999–2000. This is mainly due to full-year provision for the continued employment of non-civil service contract staff and provision for recurrent consequences of capital projects completed in 1999–2000.

Subventions

8 Provision of \$1,237,000 under *Subhead 452 Society for the Prevention of Cruelty to Animals (Hong Kong)* is for subventing the Society to meet part of the expenses of collecting and disposing of unwanted and stray dogs, cats and other mammals, public education programmes concerning prevention of cruelty to animals, rabies control and prevention, and activities associated with enforcement of the Prevention of Cruelty to Animals Ordinance (Cap. 169).

9 Provision of \$80,000 under *Subhead 455 Network of Aquaculture Centres in Asia and the Pacific* is to meet Hong Kong's annual contribution towards this organisation which provides technical information on aquaculture productivity, economics and management, and training courses and workshops of direct relevance to the development of aquaculture industries in Hong Kong.

10 Provision of \$192,000 under *Subhead 456 World Wide Fund for Nature (Hong Kong)* is for subventing the World Wide Fund for Nature (Hong Kong) to meet part of the management costs of the Island House education programme and the Educational Mobile Unit.

11 Provision of \$3,230,000 under Subhead 522 Subventions to conservation and management of Ramsar site is for subventing non-government organisations to meet part of the expenses in conserving, maintaining, improving and creating habitats, and providing education programmes for the conservation of the Ramsar site at Mai Po and Inner Deep Bay. The decrease of \$170,000 (5.0%) against the revised estimate for 1999–2000 is due to savings identified under the Enhanced Productivity Programme.

12 Provision of \$1,180,000 under Subhead 609 Minor irrigation works in the New Territories (block vote) is for a programme to provide irrigation works to assist agricultural development in the New Territories up to a limit of \$700,000 for each project.

13 Provision of \$9,200,000 under Subhead 610 Minor recreational facilities and roadworks in country parks (block vote) is for minor works such as fire lookouts, public toilets, shelters and roads up to a limit of \$500,000 for each project, and for building materials for recreational facilities such as barbecue pits, information boards, shelters and outdoor furniture.

14 Provision of \$2,810,000 under *Subhead 661 Minor plant, vehicles and equipment (block vote)* represents an increase of \$592,000 (26.7%) over the revised estimate for 1999–2000. This is mainly due to increased requirement for equipment.

Other Non-Recurrent

15 Provision of \$4,320,000 under *Subhead 844 Minor conservation projects and studies (block vote)* is for conducting conservation, education and management projects and studies, up to a limit of \$2,000,000 each, particularly those in relation to the Ramsar site at Mai Po and Inner Deep Bay.
