# **Analysis of Financial and Staffing Provision**

# Programme (1)

Provision for 2000–01 is \$2.2 million (2.1%) higher than the revised estimate for 1999–2000. This is mainly due to salary increments for existing staff, full-year provision for posts created and filled in 1999–2000, appreciation of local currencies of some of the host countries, and the engagement of consultancy services on commercial relations and non-trade issues in Europe.

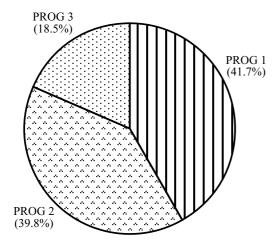

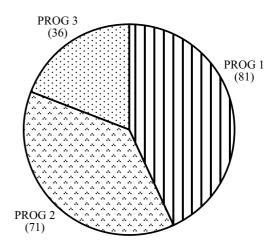

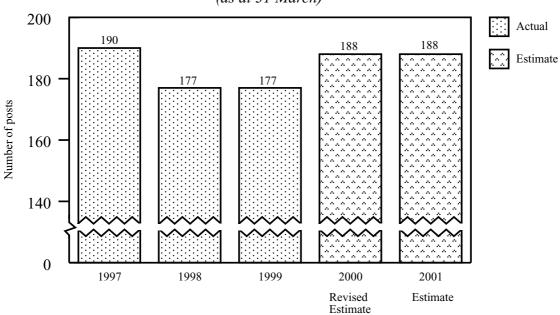
Allocation of provision to programmes (2000-01)

#### **Details of Expenditure by Subhead**

The estimate of the amount required in 2000-01 for the salaries and expenses of the Overseas Offices is \$261,710,000. This represents an increase of \$4,359,000 over the revised estimate for 1999–2000 and of \$27,462,000 on actual expenditure in 1998–99.

2 Certain items of expenditure are incurred in Hong Kong dollars, and these will be charged directly to the appropriate subheads in the amounts incurred. Expenditure in local currency incurred by the seven non-US based offices will be charged to the appropriate subheads at the following exchange rates (the spot rates on 10 December

- 3 Provision of \$127,357,000 for personal emoluments represents an increase of \$2,433,000 over the revised estimate for 1999-2000 and takes into account salary increments for existing staff and full-year provision for posts created and filled in 1999-2000.
- 4 The establishment at 31 March 2000 will be 188 permanent posts. Of the 188 permanent posts, 122 are staff engaged locally by the overseas offices. No change in establishment is expected by 31 March 2001.
- 5 Subject to certain conditions, the controlling officer may under delegated powers create or delete non-directorate posts during 2000–01, but the notional annual mid-point salary value of all such posts must not exceed \$66,219,000.

- **9** Provision of \$616,000 under *Subhead 217 Grants to organisations* is for grants, donations and subsidies to international trade and economic organisations and local organisations in various overseas locations. This is to help them towards their running costs, researches and publications, including costs of organising publicity, public relations and cultural activities.
