### Controlling Officers' Reports and Analysis of Financial Provision

This Head provides for subventions to a number of local organisations, and for Hong Kong's participation in a number of international organisations.

#### Policy Area 6: Commerce and Industry

### Permanent Secretary for Commerce, Industry and Technology (Commerce and Industry)

Subhead 437 Hong Kong-Japan Business Co-operation Committee (HKJBCC)

- **2** Provision of \$3,610,000 is for subventing the HKJBCC, which was formed in 1979 to foster friendship and understanding between the business communities of Hong Kong and Japan and to promote trade, investment and economic co-operation.
- 3 Since its inception, the HKJBCC and its counterpart, the Japan-Hong Kong Business Co-operation Committee, have been meeting at least once a year alternately in Hong Kong and Japan to update and discuss trade and economic issues. The HKJBCC is currently supported by a Communication Working Group to lead and facilitate the communication strategies and tools that help to advance the objectives of the HKJBCC.
- **4** The Committee's priority is to explore ways of promoting Hong Kong as a trade services platform where Japanese entrepreneurs can expand their manufacturing capabilities and markets, especially in the Mainland of China. Key projects spearheaded by the HKJBCC include:
  - the publication of a practical business guide book in Japanese promoting Hong Kong as the partner and platform for the Mainland of China;
  - the issuance of a monthly e-newsletter providing a steady flow of news in Japanese about business opportunities in Hong Kong for Japanese companies. This e-newsletter is distributed by email to Japanese companies on TDC's databank and can be accessed on the Japanese interface site of *tdctrade.com*;
  - providing summaries in Japanese of selected TDC research reports that are of interest to Japanese companies, especially those providing and analysing details of China's evolving trade regime under its WTO commitments. The reports can also be accessed by the Japanese companies through the internet or the aforesaid e-newsletter; and
  - conducting in-depth research and surveys to find out how Japanese companies are using Hong Kong as the services platform for their business in the Mainland and their perception of the Mainland market. The findings will be very useful and important to both Japan and Hong Kong.
- **5** The Hong Kong Trade Development Council (see Head 177—Subventions: Non-Departmental Public Bodies *Subhead 444*) will provide an additional \$358,000 to the Committee in 2003–04.

Subhead 461 United Nations Development Programme (UNDP)

**6** Provision of \$308,000 is to meet the annual contribution for 2003 towards the costs of the UNDP's activities benefiting Hong Kong and part of the administrative costs of the UNDP country office which deals with UNDP matters relating to Hong Kong. Hong Kong benefits from the UNDP in terms of overseas training and expert advisory and consultancy services.

Subhead 457 World Customs Organisation (WCO)

7 Provision of \$260,000 is to pay for Hong Kong's contribution to the 2003–04 WCO budget. The objectives of the WCO are to improve and harmonise customs systems and procedures and to facilitate international trade.

Subhead 420 Asian and Pacific Development Centre (APDC)

**8** Provision of \$88,000 is to meet the annual contribution of US\$11,220 to the APDC. In contributing to the APDC, Hong Kong is able to nominate participants to attend the training courses and seminars organised by the Centre, and benefit from the Centre's consultancy and information on development.

#### **Policy Area 9: Internal Security**

#### **Permanent Secretary for Security**

Subhead 462 United Nations International Drug Control Programme (UNDCP) and World Health Organisation (WHO)

**9** Provision of \$224,000 is to meet the annual contribution towards the UNDCP and the WHO in support of their activities to control drug trafficking and substance abuse.

Subhead 521 Skills centres

10 Provision of \$117,948,000 is for subventing on a deficiency basis three skills centres run by the Vocational Training Council, which provide vocational assessment and training services to people with disabilities over the age of 15. Key performance indicators are:

Subhead 460 United Nations Children's Fund

14 Provision of \$131,000 comprises a donation of \$88,000 towards the United Nations Children's Fund and a contribution of \$43,000 towards the Fund's administrative expenses in 2003–04. The Fund is the largest development organisation in the world that works for the well-being of children.

Subhead 527 Open University of Hong Kong

15 Provision of \$1,261,000 is for the reimbursement of rates paid by the Open University of Hong Kong.

#### **Permanent Secretary for Home Affairs**

Subhead 475 Outward Bound Trust of Hong Kong

16 Provision of \$1,911,000 is to assist deserving underprivileged or disabled persons and young people at risk, who are unable to meet all or part of the course fees, to take courses at the Outward Bound School. The courses are designed to develop the character, community spirit and leadership qualities of the participants. The key performance measures are:

- 17 Provision of \$27,425,000 is to assist 25 holiday camps and water sports centres managed by 12 non-government organisations to provide recreational activities for members of the public. The subvention helps towards meeting operating expenses on staff costs, rents and rates, and minor repairs.
- 18 In 2003–04, the Leisure and Cultural Services Department will continue to pay frequent visits to the 25 camps and centres and assist the 12 non-government organisations in maximising the utilisation of these facilities. The department will hold regular meetings with these organisations to exchange information and ideas. The department will also attend relevant meetings with the Home Affairs Bureau and relevant departments. Through these channels, the department will maintain close contact with staff of these camps and centres, and will review their facilities, programmes and mode of operation and recommend changes and improvements where necessary. Subhead 451 Hong Kong Life Saving Society

19 Provision of \$547,000 is for subvention to the Hong Kong Life Saving Society to meet part of its administration expenses. The Society promotes interest in life saving work and water safety training in Hong Kong.

Subhead 502 Hong Kong Archaeological Society

20 Provision of \$164,000 is a discretionary grant to the Hong Kong Archaeological Society to meet the expenses incurred in connection with the excavation activities conducted for the study and preservation of Hong Kong's archaeological heritage.

#### Policy Area 20: Legal Aid

## **Director of Administration**

Subhead 446 Duty Lawyer Service (DLS)

21 Provision of \$101,619,000 is for subventing the DLS in the implementation of three legal assistance schemes to complement the legal aid services provided by the Legal Aid Department. These schemes are the Duty Lawyer Scheme, the Legal Advice Scheme and the Tel-Law Scheme. The DLS, which was known as the Legal Advice and Duty Lawyer Scheme until its incorporation in August 1993, is managed by the Hong Kong Bar Association and the Law Society of Hong Kong through a governing council and is administered by an administrator who is a legally qualified person.

- 22 The Legal Aid Department provides legal representation in both civil and criminal cases heard in the District Court and above under the Legal Aid Ordinance and the Legal Aid in Criminal Cases Rules. To ensure access to justice on matters outside the jurisdiction of the Legal Aid Department, the Duty Lawyer Scheme provides legal representation to any defendant in Magistrates' Courts where the interests of justice require, and without payment by the defendant in any such case if he does not have sufficient means to pay for it. The Scheme also provides, either with the agreement or at the request of the Government, other forms of legal assistance and advice. These at present include assigning lawyers to advise defendants facing extradition, to monitor one-way viewer identification parades and to represent hawkers upon their appeals to the Municipal Services Appeals Board and any person who is at risk of criminal prosecution as a result of giving incriminating evidence in Coroner's inquest.
- 23 The Legal Advice Scheme provides free legal advice without means testing at nine evening centres at Sha Tin, Tsuen Wan, Wan Chai, Central and Western, Yau Tsim Mong, Kwun Tong, Eastern, Islands and Wong Tai Sin District Offices. In addition, the Scheme provides advice at the offices of the Hong Kong Federation of Women's Centres and the Hong Kong Federation of Women. Members of the public can make appointments to see volunteer lawyers through one of the 122 referral agencies which include all district offices and many voluntary agencies. The DLS has generally met its target of arranging a client of the Scheme to see volunteer lawyers at a centre of his choice within two weeks upon confirmation of an appointment.
- 24 The Tel-Law Scheme is a 24-hour free telephone enquiry service which provides members of the public with basic information on the legal aspects of everyday problems. There are 73 tapes available in Cantonese, English and Putonghua, covering matrimonial, landlord and tenant, criminal, financial, employment and administrative law. The website of the DLS was formally launched on 15 April 2002. It provides comprehensive information on DLS's services to members of the public, including an on-line version of the Tel-Law service.

#### **Details of Expenditure by Subhead**

The estimate of the amount required in 2003–04 for subventing or subscribing to the various organisations and institutions in and outside Hong Kong under this Head is \$268,416,000. This represents a decrease of \$27,147,000 against the revised estimate for 2002–03 and of \$21,586,000 against actual expenditure in 2001–02. Details of expenditure in respect of subheads where there are significant changes in provision are described hereunder.

#### Recurrent Account

#### Subventions

- **2** Provision of \$117,948,000 under *Subhead 521 Skills centres* represents a decrease of \$22,352,000 (15.9%) against the revised estimate for 2002–03. This is mainly due to the transfer of recurrent subventions for two skills centres run by non-governmental organisations to the respective vote under the Social Welfare Department.
- **3** Provision of \$4,022,000 under *Subhead 528 Guardianship Board* represents a decrease of \$235,000 (5.5%) against the revised estimate for 2002–03. This is mainly due to the payment of an end-of-contract gratuity for the Chairperson in 2002–03, partly offset by the effect of salary increments and end-of-contract gratuities for staff of the Guardianship Board in 2003–04.

#### Capital Account

#### Subventions

- **4** Provision of \$3,703,000 under *Subhead 863 Non-government organisation camps (block vote)* is to assist the subvented camps/centres to undertake major repairs, maintenance and improvement works with the cost of each individual item above \$50,000 but not exceeding \$2,000,000.
- **5** Provision of \$3,728,000 under *Subhead 864 Skills centres (block vote)* is for repair and maintenance works for the three skills centres run by the Vocational Training Council, replacement of the centre bus for Kwun Tong Skills Centre, and periodic testing and inspection of electrical installation for Pokfulam Skills Centre. The decrease of \$2,232,000 (37.4%) against the revised estimate for 2002–03 is mainly due to reduced requirement for repair and maintenance works.
