Aim

2 The aim is to promote building safety, enforce building standards and improve the quality of building development.

Brief Description

- 3 With this aim, the Department provides services to owners and occupants in both existing and new buildings in the private sector through enforcement of the Buildings Ordinance.
- **4** As regards existing buildings, the services provided include reducing dangers and nuisances caused by unauthorised building works and advertisement signboards; promoting proper repairs and maintenance of old buildings, drainage and slopes; considering and approving alteration and addition works; improving fire safety measures in buildings and providing advice on the suitability of premises for the issue of licences.
- **5** As regards new buildings, the Department scrutinises and approves building plans, carries out audit checks on construction works and site safety and issues occupation permits upon completion of new buildings.
- **6** In 2006, the Department continued to take enforcement action against unauthorised building works and to require building owners to carry out necessary repairs to dilapidated buildings. In addition, the Department:

Existing Buildings

- assisted the Licensing Authority in the implementation of improvement measures to streamline the processing of cinema licences;
- maintained the strengthened service of inspecting within 48 hours unauthorised building works under construction upon receipt of complaints;
- instigated 3 042 prosecutions against failure to comply with removal orders on unauthorised building works;
- extended the operation of the pilot joint office with the Food and Environmental Hygiene Department (FEHD) to handle public complaints about water seepage problems in the whole territory under a three-year programme;
- in collaboration with the Hong Kong Housing Society (HKHS), continued to implement the modified Co-ordinated Maintenance of Buildings Scheme to assist owners of 153 target buildings in carrying out the required repair/improvement works;
- inspected buildings erected between 1946 and 1958 to require removal of unauthorised building works and repair of buildings which were found dilapidated;

• initiated an operation to take enforcement action against unauthorised large glass panels, advertisement signboards and TV displays installed on the external walls of 300 target buildings in areas with heavy pedestrian flow and commercial activities;

New Buildings

- completed public consultation on the revised requirements for the provision of facilities in buildings for persons with a disability and the elderly persons; and
- continued the review of the Building Regulations to modernise building design and construction standards.

Up to 31 December 2006, 1 809 commercial premises have been jointly inspected with the FSD since the implementation of the Fire Safety (Commercial Premises) Ordinance in May 1997 and 1 291 premises were subsequently identified as PCPs. On the whole, a total of 1 803 fire safety directions (FSDns) were issued by the BD in which 1 081 FSDns were complied with/discharged and 688 PCPs have completed the improvement works or the relevant FSDns have been discharged.
- ¶ During the years 2005 and 2006, 148 and 140 potential SCBs were jointly inspected with the FSD in which 141 and 128 buildings were subsequently identified as SCBs respectively. Up to 31 December 2006, 1 380 commercial buildings have been jointly inspected with the FSD since the implementation of the Fire Safety (Commercial Premises) (Amendment) Ordinance in June 1998 and 1 260 buildings were subsequently identified as SCBs. On the whole, a total of 20 521 fire safety improvement directions (FSIDns) were issued by the BD in which 8 449 FSIDns were complied with/discharged and 280 SCBs have completed the improvement works or the relevant FSIDns have been discharged.
- ^ The drop in the estimated number of FSIDns to be issued in 2007 is due to the fact that fewer SCBs will be inspected in the year and more of them are single-owner properties requiring the issue of one FSIDn only.
- ∇ The anticipated rise in the number of FSIDns to be discharged in 2007 is due to the increase in the number of FSIDns issued in recent years.

Matters Requiring Special Attention in 2007-08

- 8 During 2007–08, the Department will take forward initiatives in all areas of its work. In particular, it will:
- sustain action to improve building safety, targeting 1 000 old buildings for carrying out blitz clearance of unauthorised building works on the external walls and repair of building defects, and 700 single-staircase buildings for clearance of illegal rooftop structures;
- in respect of the removal of unauthorised building works, take vigorous enforcement action to achieve compliance of outstanding removal orders and continue to instigate 3 000 prosecutions in 2007;
- continue to provide assistance to building owners in maintaining their buildings under the Comprehensive Building Safety Improvement Loan Scheme;
- roll out a web-based system for retrieval of building plans and records in the form of electronic images;
- continue to develop a performance-based regulatory system to facilitate modern and innovative building design;
- introduce amendments to the Buildings Ordinance to establish a minor works control regime to regulate small-scale building works more effectively;
- carry out an interim review after the extension of the operation of the joint office with the FEHD to handle public complaints about water seepage problems in the whole territory for 18 months;
- sustain a public education and publicity campaign on the need for periodical safety inspection and maintenance of buildings;
- continue to develop a performance-based fire code to facilitate modern fire safety design of buildings;
- continue to collaborate with the HKHS and the Urban Renewal Authority in speeding up the rehabilitation of old buildings by providing technical and financial assistance to owners in need;
- consider developing building design guidelines that support sustainable urban living space in Hong Kong;

- take enforcement actions to remove more abandoned signboards; and
- continue to take enforcement action against unauthorised large glass panels, advertisement signboards and TV displays installed on the external walls of another batch of target buildings in areas with heavy pedestrian flow and commercial activities.



Analysis of Financial and Staffing Provision

Provision for 2007–08 is \$20.5 million (2.7%) higher than the revised estimate for 2006–07. This is mainly due to the salary increments for existing staff, full-year effect of the extension of the operation of the joint offices with the FEHD to handle public complaints about water seepage problems in the whole territory, as well as additional provision required for the removal of abandoned advertisement signboards and processing of inter-departmental referrals of planning and building development proposals. In addition, four posts will be created in 2007–08.
