### Analysis of Financial and Staffing Provision

Provision for 2022–23 is \$16.0 million (8.8%) higher than the revised estimate for 2021–22. This is mainly due to the increased salary provision for filling of vacancies and staff changes.





### **Details of Expenditure by Subhead**

The estimate of the amount required in 2022–23 for the salaries and expenses of the Census and Statistics Department is \$786,767,000. This represents a decrease of \$233,614,000 against the revised estimate for 2021–22 and \$42,674,000 against the actual expenditure in 2020–21.

**2** Provision of \$786,267,000 under *Subhead 000 Operational expenses* is for the salaries, allowances and other operating expenses of the Census and Statistics Department. The decrease of \$233,795,000 (22.9%) against the revised estimate for 2021–22 is mainly due to the reduced provision for the 2021 Population Census, partly offset by the increased salary provision for filling of vacancies and staff changes.

**3** The establishment as at 31 March 2022 will be 1 275 permanent posts. It is expected that there will be a decrease of 24 permanent posts in 2022–23. Subject to certain conditions, the controlling officer may under delegated power create or delete non-directorate posts during 2022–23, but the notional annual mid-point salary value of all such posts must not exceed \$561,324,000.
