Aim

2 The aim is to provide the Electoral Affairs Commission with administrative support for the effective discharge of its statutory functions under the Electoral Affairs Commission Ordinance (Cap. 541) to ensure that elections are conducted openly, honestly and fairly.

Brief Description

3 The Registration and Electoral Office (REO), under the direction of the Electoral Affairs Commission, implements the decisions of the Commission in relation to:

- the review and delineation of geographical constituencies for the Legislative Council and District Council constituencies;
- the registration of electors; and
- the conduct and supervision of elections.

4 During 2021–22, the REO provided the Electoral Affairs Commission with administrative support to accomplish a number of major tasks, including:

- the conduct of a voter registration exercise;
- the publication of registers of electors for geographical constituencies, functional constituencies and Election Committee subsectors;
- the conduct of checks on electors in the current register in respect of their registered addresses;
- the conduct of cross-matching exercise with other government departments on electors' registration particulars;
- publicity measures to remind electors to update their addresses with the REO with provision of address proofs as appropriate;
- the review of subsidiary legislation on voter registration and electoral arrangements;
- the publication of an interim register and a final register of members of the Election Committee;
- the conduct of special voter registration arrangement between 1 June and 5 July 2021 to allow individuals and bodies whose eligibility was affected and those newly eligible under the Improving Electoral System (Consolidated Amendments) Ordinance 2021 to handle their voter registration matters;
- the updating and issue of guidelines for the conduct of the 2021 Election Committee Subsector Ordinary Elections, the 2021 Legislative Council General Election, and the 2022 Chief Executive Election;

- the conduct and supervision of the 2021 Election Committee Subsector Ordinary Elections, the 2021 Legislative Council General Election and the 2022 Chief Executive Election;
- the submission of the report to the Chief Executive on the 2021 Legislative Council General Election;
- the updating of guidelines for the conduct of the 2023 Rural Ordinary Election; and

Matters Requiring Special Attention in 2022–23

6 During 2022–23, the REO will continue to provide the Electoral Affairs Commission with administrative support in connection with its work, which includes:

- the conduct of a voter registration exercise, including updating the registers of electors and the related publicity measures to encourage eligible persons to register as electors and to remind members of the public of the requirement of submitting address proof for both applications for change of registered addresses and new registrations as electors;
- the conduct of checks on electors in the current registers in respect of their registered particulars, including cross-matching exercise with other government departments;


- the introduction of enhancement measures for inspection and compilation of the registers of electors effective from May 2022, including partially redacting all electors' particulars on the registers of electors, limiting inspection to the press, candidates and political parties only and extending the address proof requirement to all new voter registration applications;
- the review of overall electoral arrangements with a view to making improvements in future elections;
- the making of subsidiary legislation on voter registration and electoral arrangements as necessary;
- the supervision of the conduct of one Rural by-election and the 2023 Rural Ordinary Election;
- the conduct and supervision of the Legislative Council and District Council by-elections, if any;
- the submission of reports to the Chief Executive on the 2022 Chief Executive Election (including the 2021 Election Committee Subsector Ordinary Elections), one Rural by-election and other by-elections, if any;
- the updating and issue of guidelines for the conduct of the 2023 Rural Ordinary Election;
- the preparation of the 2023 District Council Ordinary Election; and
- the registration of specified particulars relating to candidates on ballot papers for use in the Legislative Council and District Council elections.

Analysis of Financial and Staffing Provision

Provision for 2022–23 is \$325.6 million (21.3%) lower than the revised estimate for 2021–22. This is mainly due to the reduction in requirements upon completion of the 2021 Election Committee Subsector Ordinary Elections and the 2021 Legislative Council General Election, partly offset by the increased requirements for the conduct of the 2022 Chief Executive Election, the preparation of the 2023 District Council Ordinary Election as well as the provision reserved for the preparation and conduct of any possible by-elections. There will also be a net decrease of two posts in 2022–23.

Details of Expenditure by Subhead

The estimate of the amount required in 2022–23 for the salaries and expenses of the Registration and Electoral Office (REO) is \$1,205,329,000. This represents a decrease of \$325,572,000 against the revised estimate for 2021–22 and an increase of \$474,664,000 over the actual expenditure in 2020–21.

Operating Account

Recurrent

2 Provision of \$1,205,329,000 under *Subhead 000 Operational expenses* is for the salaries, allowances and other operating expenses of the REO. The decrease of \$325,572,000 (21.3%) against the revised estimate for 2021–22 is mainly due to the reduction in requirements upon completion of the 2021 Election Committee Subsector Ordinary Elections and the 2021 Legislative Council General Election, partly offset by the increased requirements for the conduct of the 2022 Chief Executive Election, the preparation of the 2023 District Council Ordinary Election as well as the provision reserved for the preparation and conduct of any possible by-elections.

3 The establishment as at 31 March 2022 will be 312 posts. It is expected that there will be a net decrease of two posts in 2022–23. Subject to certain conditions, the controlling officer may under delegated power create or delete non-directorate posts during 2022–23, but the notional annual mid-point salary value of all such posts must not exceed \$188,071,000.
