Aim

2 The aim is to provide the Electoral Affairs Commission with administrative support for the effective discharge of its statutory functions under the Electoral Affairs Commission Ordinance (Cap. 541) to ensure that elections are conducted in an open, honest and fair manner.

Brief Description

- 3 The Registration and Electoral Office (REO), under the direction of the Electoral Affairs Commission, implements the decisions of the Commission in relation to:
 - the review and delineation of Legislative Council geographical constituencies and District Council geographical constituencies;
 - the registration of electors, voters and ex-officio members of the Election Committee; and
 - the conduct and supervision of elections.
- 4 During 2023–24, the REO provided the Electoral Affairs Commission with administrative support to accomplish a number of major tasks, including:
 - the conduct of a voter registration exercise;
 - the publication of registers of electors/voters for geographical constituencies, functional constituencies, Election Committee subsectors and the District Committees constituencies register;
 - the conduct of checks on electors in the current registers in respect of their registered addresses/registration eligibilities;
 - the conduct of cross-matching exercises with other government departments on electors' registration particulars;
 - publicity measures to remind electors to update their addresses with the REO with provision of address proofs;
 - the review of subsidiary legislation on voter registration and electoral arrangements;
 - the updating of the registers of members of the Election Committee and the District Committees constituencies;
 - the updating and issue of guidelines for the conduct of the 2023 District Council Ordinary Election;
 - the conduct and supervision of the 2023 District Council Ordinary Election;
 - the submission of the reports to the Chief Executive on the 2023 Rural Ordinary Election and the 2023 District Council Ordinary Election; and
 - the annual registration of specified particulars relating to candidates on ballot papers.

 - the conduct and supervision of by-elections, if any;
 - the submission of reports to the Chief Executive on the conduct of by-elections, if any; and
 - the annual registration of specified particulars relating to candidates on ballot papers.

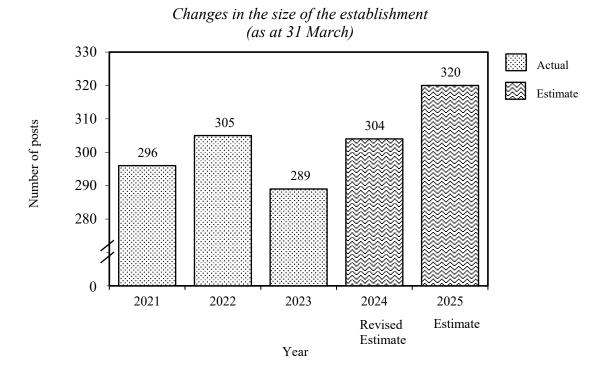

Details of Expenditure by Subhead

The estimate of the amount required in 2024–25 for the salaries and expenses of the Registration and Electoral Office (REO) is \$800,741,000. This represents a decrease of \$478,036,000 against the revised estimate for 2023–24 and \$45,804,000 against the actual expenditure in 2022–23.

Operating Account

Recurrent

- **2** Provision of \$800,741,000 under *Subhead 000 Operational expenses* is for the salaries, allowances and other operating expenses of the REO. The decrease of \$478,036,000 (37.4%) against the revised estimate for 2023–24 is mainly due to the decreased requirements for election expenses.
- 3 The establishment as at 31 March 2024 will be 304 posts including two supernumerary posts. It is expected that there will be a net increase of 16 posts in 2024–25. Subject to certain conditions, the controlling officer may under delegated power create or delete non-directorate posts during 2024–25, but the notional annual mid-point salary value of all such posts must not exceed \$204,248,000.
